- **Fees: \$10 per space.** *Checks made payable to Treasurer of Chester County.* Accepted organizations will receive notice to confirm participation. Organizations who the committee determines would not be appropriate for the event will also be notified and payment returned.
- **Display Space:** Space is approximately 10' x 10' in grass field. We strongly encourage exhibitors to provide an activity or interactive display to engage visitors. **Please do not plan on selling items; this is a free event to promote community awareness.** To evenly distribute booth placement, an accurate description of your display is required. We do not offer tables, chairs or protection from the weather. You are strongly encouraged to bring a small canopy.
- **Set-Up:** Booths must be open and staffed by 4:00 PM. Park staff will be available 1:30 – 3:00 PM to assist with your space assignment. Exhibitor staff may drive into the event field to unload, but all vehicles must be moved by 3:30 PM to exhibitor or general parking. Exhibitors are asked to operate until 7:30 PM. Fireworks start at 9:30pm; all exhibitors must be out of the event area before 8:30 pm.
- **Anticipated Attendance:** over 2,500
- **Parking:** Exhibitors will receive one (1) pass to park in the Exhibitor parking area. All others must park in the general parking lot at Valley Creek Corporate Center.
